According to the financial statements for the 4th quarter of 2025 of Det May 7 Joint Stock Company, after-tax profit increased by more than 10% compared with the same period reported in 2024. Specifically, after-tax profit in the 4th quarter of 2025 reached VND 40,415,088,716, an increase of VND 30,785,759,358 compared to the same period in 2024.

- In the 4th quarter of 2025, the Company focused all resources on production and sales. The newly invested machinery and equipment system, which became operational in the 4th quarter of 2025, increased productivity, reduced costs, and significantly improved production efficiency. Sales revenue reached VND 345,686,599,596, an increase of VND 54,485,549,203 compared with the same period reported in 2024.
